13. As at 9am on 15 April 2014, the Company's issued share capital comprised 85,959,729 ordinary shares of 20p each. Each ordinary share carries the right to one vote at a general meeting of the Company. The Company holds 8,922,900 ordinary shares in treasury and therefore, the total number of voting rights in the Company as at 9am on 15 April 2014 is 77.036.829.
