INTRODUCTION

I am writing to you to explain the resolutions which will be proposed at the Company's 2019 Annual General Meeting. Notice of the Annual General Meeting convened for Friday, 17 May 2019 is attached at the end of this document.

The Board is of the view that, in order to encourage a more efficient dialogue with shareholders at the Annual General Meeting, shareholders should be able to let the Directors know in advance of any questions they would like to raise so as to permit the Directors to give shareholders more considered and useful answers. Accordingly, this letter also explains the method by which questions can be asked in advance of the meeting.

The Board believes that it continues to be in the best interests of the Company and its shareholders that the Company be in a position to return surplus funds to shareholders should they decide to do so. Having reviewed the alternative methods of returning value to shareholders, the Directors believe that the buying back by the Company of its ordinary shares in the market continues to be an effective way. Accordingly, the Directors are seeking the approval of shareholders to renew the authority for the Company to purchase up to 7,587,433 of its own ordinary shares in the market, equivalent to 10 per cent of the Company's ordinary share capital (excluding treasury shares).

ANNUAL REPORT AND ACCOUNTS

The Company announced its results for the year ended 31 December 2018 on 1 March 2019. The Annual Report and Accounts which you will also have received contains a statement from myself, a statement from the Chief Executive, Robert Walters and a financial review from the Chief Financial Officer, Alan Bannatyne. The Annual Report and Accounts also contain the Group's financial statements for the year ended 31 December 2018 and reports from the Directors and the Company's Auditor, Deloitte LLP.

Shareholder approval is now required to be sought for the Directors' Remuneration Report (other than the part containing the Directors' Remuneration Policy) for the year ended 31 December 2018 at the forthcoming Annual General Meeting. This report is contained on pages 46 to 65 (inclusive) of the Annual Report and Accounts. The Directors' Remuneration Policy, which starts on page 59 of the Annual Report and Accounts, was approved at the 2017 Annual General Meeting and will remain in force for three years from the date of that approval. This is a binding policy and Directors' remuneration must be consistent with it.

As referred to in the Annual Report and Accounts on page 67, the Directors propose to recommend the payment of a final dividend of 10.7p per ordinary share to be paid on Monday, 3 June 2019 to the ordinary shareholders that are listed on the members' register on Friday, 10 May 2019.

ANNUAL GENERAL MEETING

At the end of this letter is the notice convening the Annual General Meeting. The meeting, which is to be held at 10:30am on Friday, 17 May 2019 at 11 Slingsby Place, St. Martin's Courtyard, London WC2E 9AB, will comprise both ordinary and special business.

Ordinary Business

The first part of the meeting will consider the following matters that comprise the ordinary business of the meeting and which will be proposed as ordinary resolutions:

- **Approval of the Accounts of the Company for the year ended 31 December 2018 and the reports of the Directors and Auditor thereon (resolution 1)**

The Directors of the Company must present the Accounts to the Annual General Meeting.

- **Approval of the Directors' Remuneration Report for the year ended 31 December 2018 (other than the part containing the Directors' Remuneration Policy) (resolution 2)**

The Companies Act 2006 (the "2006 Act") requires the Company to seek shareholder approval of the Directors' Remuneration Report for the year ended 31 December 2018 (other than the part containing the Directors' Remuneration Policy). You can find the Report on pages 46 to 58 of the Annual Report and Accounts which is available on the Company's website at www.robertwalters.com. In accordance with the 2006 Act, this is an advisory vote and the Directors' entitlement to receive remuneration is not conditional on it.

- **Approval of a final dividend of 10.7p per ordinary share for the year ended 31 December 2018 payable to shareholders on Monday, 3 June 2019 who were on the register on Friday, 10 May 2019 (resolution 3)**

A final dividend can only be paid after the shareholders at a general meeting have approved it. A final dividend of 10.7p per ordinary share is recommended by the Directors for payment to shareholders who are on the register at the close of business on Friday, 10 May 2019. If approved, the date of payment of the final dividend will be Monday, 3 June 2019.

None of the Directors are required by the UK Corporate Governance Code to retire at this year's Annual General Meeting; however, each Director is offering themselves for re-election as a matter of corporate governance in order that all the Directors are subject to annual re-election.

- **Re-election of Carol Hui as a Director of the Company (resolution 4)**

Carol Hui, who was appointed as a Non-executive Director in January 2012 and as Chairman of the Board in March 2018, retires in accordance with the current Articles of Association of the Company (the "Current Articles") and is offering herself for re-election by the shareholders. Carol is a member of the Nominations Committee. Her biography is on page 70 of the Annual Report and Accounts and appears on the Company's website at www.robertwalters.com.

- **Re-election of Robert Walters as a Director of the Company (resolution 5)**

Robert Walters, who was appointed as Chief Executive Officer and as an Executive Director in July 2000, retires in accordance with the Current Articles and is offering himself for re-election by the shareholders. Robert is also a member of the Nominations Committee. His biography is on page 70 of the Annual Report and Accounts and appears on the Company's website at www.robertwalters.com.

- **Re-election of Alan Bannatyne as a Director of the Company (resolution 6)**

Alan Bannatyne, who was appointed as Chief Financial Officer and as an Executive Director in March 2007, retires in accordance with the Current Articles and is offering himself for re-election by the shareholders. His biography is on page 70 of the Annual Report and Accounts and appears on the Company's website at www.robertwalters.com.

- **Re-election of Brian McArthur-Muscroft as a Director of the Company (resolution 7)**

Brian McArthur-Muscroft, who was appointed as a Non-executive Director in May 2013, retires in accordance with the Current Articles and is offering himself for re-election by the shareholders. Brian is a member of the Audit and Risk, Nominations and Remuneration Committees. Brian is also the Senior Independent Director. His biography is on page 70 of the Annual Report and Accounts and appears on the Company's website at www.robertwalters.com.

- **Re-election of Tanith Dodge as a Director of the Company (resolution 8)**

Tanith Dodge, who was appointed as a Non-executive Director in February 2017, retires in accordance with the Current Articles and is offering herself for re-election by the shareholders. Tanith is a member of the Remuneration, Audit and Risk and Nominations Committees. Her biography is on page 70 of the Annual Report and Accounts and appears on the Company's website at www.robertwalters.com.

- **Re-election of Steven Cooper as a Director of the Company (resolution 9)**

Steven Cooper, who was appointed as a Non-executive Director in October 2018, retires in accordance with the Current Articles and is offering himself for re-election by the shareholders. Steven is a member of the Audit and Risk, Nominations and Remuneration Committees. His biography is on page 71 of the Annual Report and Accounts and appears on the Company's website at www.robertwalters.com.

Having considered the performance of and contribution made by each of the Directors standing for re-election, the Board remains satisfied that the performance of each of the relevant Directors continues to demonstrate commitment to the role and to be effective and, as such, recommends their re-election.

- **Appointment of BDO LLP as Auditor of the Company to hold office until the next general meeting at which accounts are laid before the Company (resolution 10)**

In compliance with the European Union Audit Directive and Regulation, the external audit contract for the 2019 audit was put out for competitive tender. Deloitte LLP did not seek re-appointment as auditors to the Company at the conclusion of its term of office expiring at the Annual General Meeting as a result of mandatory audit firm rotation requirements. Following the competition of the tender process and after due and careful consideration, the Directors recommend that BDO LLP (BDO) be appointed as the Company's Auditor. Resolution 10 is to appoint BDO as auditors of the Company to hold office from the conclusion of this meeting until the conclusion of the next Annual General Meeting of the Company at which accounts are laid before the Company.

- **Authorisation of the Directors to fix the Auditor's remuneration (resolution 11)**

The remuneration of the Company's Auditor must be fixed by the Company in general meeting or other such manner as the shareholders may determine in general meeting. This resolution authorises the Directors to approve the terms of engagement and determine the remuneration of the Auditor.

Special Business

The second part of the meeting will be held to consider the following special business, which will be proposed as to resolution 12 as an ordinary resolution and, as to resolutions 13 to 15, as special resolutions:

- **Authority to allot relevant securities in the Company (resolution 12)**

On 17 May 2018, the Directors were given authority, under section 551 of the 2006 Act, to allot up to 25,157,942 ordinary shares, representing one-third of the ordinary shares then in issue (excluding treasury shares) until the earlier of the conclusion of the 2019 Annual General Meeting and 30 June 2019. The Directors recommend, by resolution 12, that a new authority under section 551 of the Companies Act 2006 be granted, which will expire on the earlier of the conclusion of the 2020 Annual General Meeting and 30 June 2020.

If resolution 12 is approved by shareholders, the Directors will have authority to allot up to 25,291,444 ordinary shares representing one-third of the ordinary shares currently in issue (excluding treasury shares) as at 12 April 2019 (being the latest practicable date prior to the publication of this notice). The Company currently has 4,074,000 treasury shares in issue, which represents 5.37 per cent of the total share capital in issue (excluding treasury shares) as at 12 April 2019, being the last practicable date prior to the publication of this document.

The Directors have no present intention of exercising the authority except in connection with the issue of ordinary shares under the Robert Walters Executive Share Option Plan 2016, which was approved by shareholders at the 2016 Annual General Meeting. The Directors intend to renew this authority annually.

- **Dis-application of statutory pre-emption rights (resolution 13)**

On 17 May 2018, the Directors were also given authority, under section 561 of the 2006 Act, until the earlier of the conclusion of the 2019 Annual General Meeting and 30 June 2019, to allot equity securities for cash, other than to existing shareholders in proportion to their holdings, up to an aggregate nominal amount of £754,738 (3,773,691 ordinary shares), being equal to 5 per cent of the then current issued ordinary share capital. The Directors recommend, by resolution 13, that a new authority under section 561 of the 2006 Act be granted which will expire on the earlier of the conclusion of the 2020 Annual General Meeting and 30 June 2020. Resolution 13 will be proposed as a special resolution.

If resolution 13 is approved by shareholders, the Directors will be authorised to allot equity securities for cash, other than to existing shareholders in proportion to their holdings, up to an aggregate nominal amount of £758,743 (3,793,717 ordinary shares) being equal to approximately 5 per cent of the current issued ordinary share capital (excluding treasury shares) as at 12 April 2019 (being the latest practicable date prior to the publication of this notice) until the earlier of the conclusion of the 2020 Annual General Meeting and 30 June 2020. The Directors intend to renew this authority annually.

The requirements to allot equity securities for cash to existing shareholders in proportion to their holdings will also apply to the sale by the Company of any shares it holds as treasury shares. These requirements may be similarly dis-applied by shareholders. The authority sought and limits set by resolution 13 will also apply to a sale of treasury shares.

- **Authority to make market purchases of ordinary shares (resolution 14)**

The Directors recommend, by resolution 14, that the Company be authorised, for the purposes of section 701 of the 2006 Act and in substitution for any existing authority for the Company, to make market purchases of ordinary shares. The existing authority is due to expire at the conclusion of the Annual General Meeting and it is proposed that the Company be authorised to continue to make market purchases up to an aggregate of approximately 10 per cent of the Company's issued ordinary share capital (excluding treasury shares), as further described below.

The Directors will continue to exercise this power only when, in the light of market conditions prevailing at the time, they believe that the effect of such purchases will be to increase earnings per share and will be likely to promote the success of the Company for the benefit of its members as a whole. Other investment opportunities, appropriate gearing levels and the overall position of the Company will be taken into account when exercising this authority. The Company may hold in treasury any of its own shares that it purchases pursuant to the 2006 Act and the authority conferred by this resolution. This gives the Company the ability to reissue treasury shares quickly and cost-effectively and provides the Company with greater flexibility in the management of its capital base. It also gives the Company the opportunity to satisfy employee share scheme awards with treasury shares.

The proposed authority will be limited to purchases of up to 7,587,433 ordinary shares which is equal to approximately 10 per cent of the Company's issued ordinary share capital (excluding treasury shares) as at 12 April 2019 (being the latest practicable date prior to publication of this notice). The minimum price per share to be paid on any purchase will not be less than 20p, being the nominal value of each ordinary share, and the maximum price will be no more than the higher of (a) 105 per cent of the average of the middle market quotation for an ordinary share (as derived from the Daily Official List of the London Stock Exchange) for the five business days immediately preceding the day on which the ordinary shares are contracted to be purchased and (b) the higher of the price of the last independent trade and the highest current independent bid for an ordinary share on the trading venue where the purchase is carried out, in both cases exclusive of expenses payable by the Company. Save to the extent purchased pursuant to the 2006 Act, any shares purchased in this way will be cancelled and the number of shares in issue will be reduced accordingly.

As at 12 April 2019 (being the latest practicable date prior to the publication of this notice), there were outstanding options granted under all share option schemes operated by the Company of 3,978,318 shares, which, if exercised or vested (as applicable), would represent 5.24 per cent of the issued ordinary share capital of the Company (excluding any shares held in treasury). If the proposed authority were exercised in full, that percentage would decrease to 4.77 per cent.

Resolution 14 will be proposed as a special resolution to provide the Company with the necessary authority. If given, this authority will expire on the earlier of the conclusion of the 2020 Annual General Meeting and 30 June 2020.

- **Authority to hold general meetings (other than Annual General Meetings on 14 clear days' notice) (resolution 15)**

On 17 May 2018, the Company was given the ability to call general meetings (other than an Annual General Meeting) on 14 clear days' notice until the 2019 Annual General Meeting. This resolution was required to reflect the changes made to the 2006 Act by the Companies (Shareholders' Rights) Regulations 2009 (the "Shareholders' Rights Regulations"). The Shareholders' Rights Regulations increased the notice period for general meetings of the Company to 21 days unless shareholders approve a shorter period, which cannot, however, be less than 14 clear days.

If resolution 15 is approved by shareholders, the Company will be able to call general meetings (other than an Annual General Meeting) on 14 clear days' notice. The Company undertakes to meet the requirements for electronic voting under the Shareholders' Rights Regulations before calling a general meeting on 14 clear days' notice. If given, the approval will be effective until the Company's next Annual General Meeting, when it is intended that a similar resolution will be proposed. The Directors intend that this short notice period will not be used as a matter of routine for such meetings but only where the flexibility is merited by the business of the meeting and is thought to be to the advantage of shareholders as a whole.

QUESTIONS IN ADVANCE

The Board wishes to offer shareholders the opportunity to submit questions in advance of the Annual General Meeting. If you wish to put forward a question at the Annual General Meeting, you can send your questions in writing to Alan Bannatyne at Robert Walters Plc, 11 Slingsby Place, St. Martin's Courtyard, London WC2E 9AB. At the Annual General Meeting, I will address the issues which, on the basis of the questions submitted, appear to be of most interest to shareholders generally. **I wish to stress, however, that submitting a question now will not preclude you, if you attend the meeting, from asking that question, or any other question.**

ACTION TO BE TAKEN

Shareholders will find enclosed with this letter a proxy form for their use in respect of all resolutions to be proposed at the Annual General Meeting. Whether or not you intend to attend the meeting, you are asked to complete and return the proxy form as soon as possible and in any event must be received no later than 48 hours before the Annual General Meeting. Completion and return of a proxy form will not prevent you from attending the meeting and voting in person if you so wish.

RECOMMENDATION

The Board believes that all the resolutions at the Annual General Meeting are in the best interests of the Company and its shareholders as a whole. Accordingly, your Directors recommend that you vote in favour of all resolutions. The Directors intend to vote in favour of all the resolutions in respect of their own shareholdings, amounting to 4,714,402 ordinary shares representing approximately 6.21 per cent of the issued ordinary share capital (excluding treasury shares).

12. That the Directors of the Company (the "**Directors**") be and are generally and unconditionally authorised pursuant to section 551 of the Companies Act 2006 to exercise all powers of the Company to allot any shares in the Company and to grant rights to subscribe for or convert any security into shares in the Company up to an aggregate maximum nominal amount of £5,058,289, provided that this authority shall expire (unless renewed, varied or revoked by the Company in general meeting) on the earlier of the conclusion of the next Annual General Meeting of the Company to be held in 2020 and 30 June 2020, save that the Company shall be entitled to make, prior to the expiry of such authority, any offer or agreement which would or might require shares to be allotted or rights to subscribe for or convert any security into shares to be granted after the expiry of such authority and the Directors may allot shares or grant rights to subscribe for or convert securities into shares in pursuance of such offer or agreement as if the authority conferred here had not expired. The authority granted by this resolution shall replace all existing authorities to allot any shares in the Company and to grant rights to subscribe for or convert any security into shares in the Company previously granted to the Directors pursuant to section 551 of the Companies Act 2006 (save to the extent that the same are exercisable pursuant to section 551(7) of the Companies Act 2006 by reason of any offer or agreement made prior to the date of this resolution which would or might require shares to be allotted or rights to be granted on or after that date).
13. That the Directors be and are generally and unconditionally empowered, pursuant to section 571(1) of the Companies Act 2006 (a) subject to the passing of resolution 12 set out in the notice of Annual General Meeting of the Company convened for 17 May 2019, to allot equity securities (as defined in section 560 of the Companies Act 2006) for cash pursuant to the authority conferred by resolution 12; and (b) to allot equity securities as defined in section 560(3) of the Companies Act 2006 by way of a sale of treasury shares for cash, in either case as if section 561 of the Companies Act 2006 did not apply to such allotment, provided that this power shall be limited to:

- 13.1 The allotment of equity securities in connection with an offer or issue of equity securities to or in favour of:
 (a) holders of shares in proportion (as nearly as may be practicable) to their existing holdings; and (b) holders of other equity securities if this is required by the rights of those securities or, if the Directors consider it necessary, as permitted by the rights of those securities, but subject to such exclusions or other arrangements as the Directors may deem necessary or expedient in relation to fractional entitlements, treasury shares, record dates, shares represented by depository receipts, legal or practical problems arising under the laws of any territory or the requirements of any relevant regulatory body or any stock exchange or any other matter; and
- 13.2 The allotment (otherwise than pursuant to paragraph 13.1) of equity securities pursuant to the authority granted under Resolution 12 and/or by virtue of section 560(3) of the Companies Act 2006, up to an aggregate maximum nominal amount of £758,743.

This power shall (unless renewed, varied or revoked by the Company in general meeting) expire on the earlier of the conclusion of the next Annual General Meeting of the Company to be held in 2020 and 30 June 2020, save that the Company may before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities in pursuance of such offer or agreement as if the power conferred here had not expired. All previous unutilised authorities conferred under section 571 of the Companies Act 2006 shall cease to have effect and shall be and are revoked, provided that such revocation shall not have retrospective effect.

14. That the Company be and is authorised for the purpose of section 701 of the Companies Act 2006 to make market purchases (within the meaning of section 693(4) of the Companies Act 2006) of ordinary shares of 20p each in the capital of the Company ("**ordinary shares**"), on such terms and in such manner as the Directors may from time to time determine, provided that:

- 14.5 The Company may make a contract to purchase ordinary shares under this authority before its expiry which will or may be executed wholly or partly thereafter and may make a purchase of ordinary shares in pursuance of any such contract as if such authority had not expired.

 - iii) in the case of shares held through CREST, via the CREST system (see note 7 below).
3. In the case of a corporation, the form of proxy must be executed under its common seal or under the hand of any officer or attorney duly authorised.
4. You can only appoint a proxy using the procedures set out in these notes and the notes to the form of proxy.
5. Completion and return of the relevant proxy form enclosed herewith will not prevent a shareholder from attending and voting in person. If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be terminated.
6. A vote withheld is not a vote in law, which means that the vote will not be counted in the calculation of votes for or against the resolution. If no voting indication is given, your proxy will vote or abstain from voting at his/her discretion. Your proxy will vote (or abstain from voting) as he/she thinks fit in relation to any other matter which is put before the meeting.
7. CREST members who wish to appoint a proxy or proxies through the CREST electronic proxy appointment service may do so for the Annual General Meeting and any adjournment(s) of the meeting by using the procedures described in the CREST Manual. A person to whom this notice is sent who is a person nominated under section 146 of the Companies Act 2006 to enjoy information rights ("**a nominated person**") may, under an agreement between him/her and the shareholder by whom he/she was nominated, have a right to be appointed (or to have someone else appointed) as a proxy for the Annual General Meeting. If a nominated person has no such proxy appointment right or does not wish to exercise it, he/she may, under any such agreement, have a right to give instructions to the shareholder as to the exercise of voting rights.

The Company may not require the shareholders requesting any such website publication to pay its expenses in complying with Sections 527 or 528 (requirements as to website availability) of the Companies Act 2006. Where the Company is required to place a statement on a website under Section 527 of the Companies Act 2006, it must forward the statement to the Company's Auditor no later than the time when it makes the statement available on the website. The business which may be dealt with at the Annual General Meeting includes any statement that the Company has been required under section 527 of the Companies Act 2006 to publish on its website.
